SELLER'S CONTRACT  
(REVISED 7/17)

As a consignor of The Consignment Sale, I agree to the following:

1. I will receive 65% of each sale with the remaining 35% going to The Consignment Sale.
2. I understand there will be a \$8.00 selling fee deducted from my check. Unless I have \$20 or less of items at Receiving in which case I will pay the \$8 at Receiving.
3. Any unsold items as of Friday, September 22, 2023 will be sold for half price if I have chosen the "Donate" feature.
4. I understand that my final payment must be picked up Thursday, September 28th, between 6-8PM along with my unsold items.
5. It is my responsibility to have my unsold items picked up on time (this CAN be done by a friend or family member). If I am unable to be at Pick Up, I will make arrangements for someone to go in my place. Any remaining items not picked up on **Thursday, September 28, 2023**, will be donated to charity. **Pick Up is Thursday, September 28th, from 6 - 8 PM** at the sale location. **I understand \$10.00 will be deducted from my check if prior notice is not given by contacting The Consignment Sale via email subject heading "mail check" and The Consignment Sale must mail the check to my address.**
6. If the card I have placed on an item becomes lost for whatever reason and the original price cannot be determined by using reasonable means, The Consignment Sale has the right to determine a fair selling price for that item.
7. The Consignment Sale will not be held liable for any loss or damage to the items from any cause whatsoever, including, but not limited to flood, fire, theft, or damages.
8. I understand the following conditions could result in loss of some of my sales:
  - \*Not using 65# or greater, white or light pastel (no blue or pink) cardstock as requested
  - \*Not tagging items correctly
  - \*Not using the bar-coding system
9. I am aware of the Consumer Product Safety Improvement Act of 2008 and agree, to the best of my ability, that all the items I am consigning are safe for the consumer.
